Portbase

Portbase connects all parties in the logistics chains of Dutch ports. Through its Port Community System, Portbase facilitates the exchange of data between companies and the exchange of information with government authorities in order to allow everyone to work faster, more efficiently and at lower cost. Together with our growing community, we are continually adding value to this data sharing. Our goal: to make the Dutch port community, and thereby the ports themselves, the smartest in Europe. Portbase is a neutral, non profit organisation operating from within and for the port community.

Advantages

The PCS offers a wide range of services, by means of which around 15,500 users send about 94 million electronic messages a year. The majority of these services reuse the data already present in the PCS. Participants can operate with optimal efficiency.

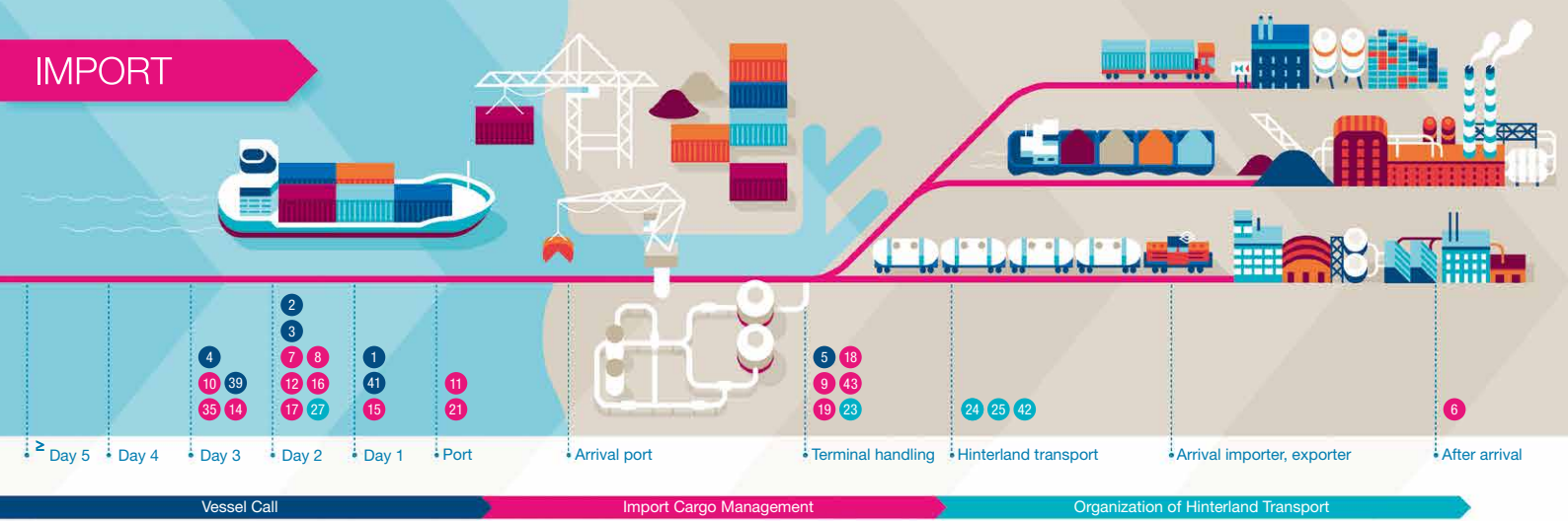

Vessel Call

Agents, shipping companies and shipbrokers in the bulk and container sector can speed up the logistic processes around vessel visits by using the Portbase services.

This improves the logistic process because authorities - such as Customs and the Harbour Master - and port authorities are informed in good time about the arrival of a ship, the cargo and the country of origin. There is also more coordination between all the parties involved. As a result, activities can be scheduled well in advance and potential risks evaluated ahead of time. Any inspections can be scheduled before the ship actually enters the port. Throughput times in ship handling are being reduced further.

Import Cargo Management

Agents, shipping companies, shipbrokers, importers and forwarders are required to notify various authorities of the cargo they want to import to the European Union. This applies to both bulk and container transport. The Portbase services make it easy to comply with these requirements.

Information is provided efficiently and transparently to all the parties involved, such as Customs and the Food and Consumer Product Safety Authority. Timely information makes a smooth flow of goods possible. Within the Portbase services, the reuse of information enables a further simplification of logistics processes.

Organization of Hinterland Transport

The port represents the gateway to and from the hinterland. Road operators, barge operators and rail hauliers use the Portbase services to deliver and collect containers at the sea terminals.

For cargo that needs to be moved to and from the port, the Portbase services provide a user-friendly way of exchanging information. Thanks to the Portbase services, terminals are informed well ahead of time and all the required information is known. As a result, logistics processes run smoothly.

Export Cargo Management

Portbase offers forwarders, exporters, agents, shipbrokers and shipping companies a one-stop-shop solution for handling the export formalities.

The Portbase services improve the flow for both bulk and container transport. They provide optimum information for all parties involved, including terminals and Customs, and make it easy for all requirements to be met. Optimum and efficient logistics from A to Z.

Cargo Declaration Export Bulk/Containers

Service for submitting your summary declarations for cargo loaded in the container sector, general cargo and bulk sector.

Cargo Declaration Import

Service for submitting summary declarations to be discharged (SAL) to Customs.

Cargo Declaration Status Report

Provides an overview at all times of your summary declarations for which no new declarations have yet been submitted. This gives you the opportunity to quickly take care of settlement.

Cargo Information

Improved service, allowing all movement details of visiting sea-going vessels and loading details of containers on board to be consulted 24/7. You no longer need to phone the shipping agent or shipbroker to generate new declarations and make the transport planning.

Clearance NCTS Export Containers

By using this service, container terminals can easily release NCTS documents for outgoing cargo (T1 and T2) electronically at Customs.

Data Service Discharge Information

Implementation of the data service Discharge Confirmation allows you - immediately after a container is discharged and automatically from within your in-house system - to confirm the pre-announcement with Customs or submit a follow-up declaration.

Declaration Food & Consumer Products

Service for submitting Common Veterinary Entry Documents (CVED) to the Netherlands Food and Consumer Product Safety Authority (NVWA).

Discharge Confirmation Report

Your summary of containers actually unloaded at the sea terminal compared to those pre-notified. This allows you to quickly complete your declarations.

Discharge Information

Practical and low-threshold service for all communication around a (liquid) bulk carrier to be discharged. BL details, stowage position and weight actually discharged are visible to the relevant parties at a glance.

Discharge List

Service for submitting discharge lists to terminals.

Discharge Difference List

Summary for Customs of the containers actually discharged compared to those shown on the manifest.

Exit Summary Declaration

Service to submit an Exit Summary Declaration (EXS) for outgoing cargo for which the safety and security data are not (or no longer) available to Customs in any other way.

Hinterland Container Notification Road/Barge

A single service for pre-notifying containers for all hinterland modalities (truck, rail, barge) to sea terminals, inland terminals and depots.

Import Status

Gain real-time insight into the Customs status of your incoming cargo at shortsea and ferry terminals.

Inland Port Dues*

Portal for skippers to submit their season ticket applications for the declaration of inland port dues. Patrol vessels (RPA) can report the vessels identified to the Port of Rotterdam Authority.

Inspection Portal

From initial request all the way to release: you can gain a complete picture of all scan and physical inspections of import cargoes taking place at the behest of Customs in all the Dutch ports.

Loading List

Easily submit your list of containers to be loaded to the terminal.

Notification Arrival ECS Cargo

Container terminals can easily notify Customs of the arrival of export cargo (arrival at exit).

Notification Arrival Export Containers

Bulk and general cargo terminals can easily notify Customs that ECS goods have reached the exit location (arrival at exit).

Notification Crew and Passengers

The most practical solution for submitting crew and passenger lists electronically to the Harbour police and Royal Netherlands Marechaussee.

Notification Dangerous Goods

Service for reporting dangerous goods on board a sea-going vessel to the Harbour Master.

Notification Export Documentation

Easily submit pre-notification of all Customs documents for export at deepsea, shortsea and ferry terminals.

Notification Import Documentation

Prenotify all your Customs documents for import to deepsea, shortsea and ferry terminals.

Notification Local Clearance 2.0

Notify Customs that goods are being taken to an entrepôt. You can automatically inform the terminal at the same time. As a result, the road haulier does not need any paper customs documentation.

Notification Ship's Stores

A practical service for easily complying with the new Customs requirement of electronically submitting your vessel's store list.

Notification Single Window

Service for port authorities to submit all information about visits to vessels and dangerous goods to SafeSeaNet (SPOC NL).

Notification Verified Gross Mass

Using a single gateway, you can easily notify shipping companies of the verified gross mass (VGM) of export containers.

Notification Waste Disposal

Service to report waste on board of a vessel to the Harbour Master.

Pre-arrival Cargo Declaration Import (4h)

Makes it easy for deepsea container shipping companies to submit an Entry Summary Declaration (ENS) to Customs.

Rail Planning

Pre-notify train compositions (bulk and containers) and cargo (discharge/loading lists of containers) to terminals, including status feedback from terminals.

Seaport Statistics*

This service supplies the Port of Rotterdam Authority, the Port of Amsterdam, Statistics Netherlands (CBS) and shipbrokers with reliable statistics about ship movements and cargo on a monthly basis.

Statement Harbour Dues Amsterdam

Service to submit statement of harbour dues to Port of Amsterdam.

Track & Trace Export

Service which allows the user to track and trace export containers online: from the moment they arrive at the terminal to their departure on board of a vessel.

Transit Declaration

Make quick and simple transit declarations (generate T-documents). You can then automatically notify the terminal of the associated Movement Reference Number (MRN). As a result, the haulier does not require any paper customs documentation.

User Management

Manage your Portbase services easily and safely. Easily keep your company details and user administration up-to-date.

Vessel Notification 1.0 en 2.0

Service to submit the vessel notification to the Harbour Master and Customs.

Veterinary Inspection Process


Optimally plan veterinary inspections at inspection stations in the port.

Wagonload Information System*

Service to track and trace dangerous goods in railway yards and siding tracks. In case of calamity the correct and complete data are available to emergency services.
